Environmental Demonstration Day



The A. Crawford Mosley High School parking lot was transformed into an outdoor classroom on May 19th, giving hundreds of students an opportunity to learn about local efforts to preserve habitat and protect wildlife. After reaching out to Mosley Science Department Chair **Lorene Lindsay**, Bay County Conservancy Board Member **Phil Mount** wasted no time getting the full-day event coordinated.

BCC partnered with experts from the Bay County Audubon Society, the US Fish and Wildlife Service, Florida Fish and Wildlife Conservation Commission and the Florida Forest Service. Students were able to meet with biologists, ecologists and forestry specialists for hands-on learning at several exhibition tables set up on the school grounds.

BCC's **Candis Harbison** and **Teresa Nooney** provided information on "Aliens vs Natives" - emphasizing the negative effects on biodiversity when exotic plants like Chinese tallow, Cogon grass, Japanese climbing fern, etc. are allowed to grow unchecked.

At the Audubon tent, **Ron Houser** showed students how to view birds with binoculars and a birding scope. FWS Biologist **Patty Kelly** and Ecologist **Harold Mitchell** had

local species of crayfish and snakes on hand, and described how habitat loss may threaten their survival.

Other highlights included a bear trap, a beach mouse burrow exhibit, sea turtle shells and nesting info, tree and leaf identification displays, information about the

benefits of prescribed burning, and various animal tracking and tagging devices.

BCC would like to thank all our environmental partners and the staff and students at Mosley High School for participating and helping make

New Trail at Audubon Nature Preserve: "The High Road"



The Audubon Nature Preserve walking trail leading from the gazebo to the north end of the property has some low points. Specifically, some portions of the path become too muddy during wet weather to trek through without rubber boots. **Jackie Kolk** asked **Duke Energy** for help with funding, and in spring BCC put some welcome grant money to good use. A new trail portion, dubbed "The High Road," has been constructed to take walkers around the wet areas.

SCA intern **Love Wootton** created an educational narrative for the trail—and in April she led groups of children and their moms on nature walks through the preserve. The kids learned about the different wetland creatures that inhabit the Doctors Pond area—and had fun exploring the trails and making nature bracelets.

Eileen Oltz Donates Property

Eileen and Russell Oltz loved their three acres of woods in College Point and the cottage that sat on one corner of it. Over the years, they added rooms to the cottage as they transitioned from part-time to full-time residence there for themselves and their two daughters. After Russell died, Eileen continued enjoying feeding peanut butter to the squirrels and walking her dogs on the paths they had made through the woods.

As Conservationists, the Oltzes were active in getting the state of Florida to declare and maintain a setback line for construction on the beach, to preserve the first dune line and leave room for turtles and birds to nest and for people to walk on the beach. Similarly, Eileen wanted to make sure that her woods were kept intact for the birds and squirrels and neighbors to enjoy. Thus, she made provision for the property to pass to the Bay County Conservancy/The Land Conservancy of NW Florida upon her death. Her remaining daughter, **Terri Oltz Minor**, has been very cooperative in making this happen after Eileen's death in January 2016.

BCC/TLC wanted to use the house as an office and nature center, but it was simply too much in need of expensive repair for that to be feasible. The house is being sold to someone who can fix it up for a nice residence, and the remaining 2 and ½ acres will be maintained as natural green space, just as Eileen wanted. A walking path will eventually be open to the public, and a sign dedicating the sanctuary as the "Oltz Family Preserve" will be erected.

10 acres added to Tumble Creek Preserve

BCC's largest protected property, the Tumble Creek Preserve, now stands at nearly 92 acres with the addition of 10 acres late last year. The land itself is in Washington County, about 38 miles north of Lynn Haven (west of Highway 231), but is also in the Econfina Creek Watershed. As rapid development continues in Florida, the need for such preserves as Tumble Creek becomes critical. Not only does it provide habitat for plants and animals, it helps to provide a secure water supply and maintain the purity of the St. Andrew Bay watershed. Bay County Conservancy—
